



Certificate IV in Hospitality

Course Overview

With the tourism sector's continued growth, there are many job openings both here in Australia and overseas, and the industry offers plenty of opportunities for progression for people with the right attitude, qualifications and experience.

The nationally recognised Certificate IV in Hospitality (SIT40416) will help you to develop the practical skills and experience needed to secure an entry-level position within this exciting field.

As part of your training, you'll enjoy 12 weeks work placement at Mantra Hotel Tullamarine, where you'll gain real-world experience in a four star hotel. You'll also hone your skills in our fully-operational licensed training restaurant at our Broadmeadows campus.

The course covers all areas of front of house operations including housekeeping, food and beverage, sales, events and customer service.

Our students graduate as highly employable professionals ready to take the next step in a rewarding and exciting career in the hospitality industry.

A number of our top performing students have been offered positions at Mantra Hotel Tullamarine upon completion of their studies.

Career Opportunities

This course is designed to give you the skills and experience to secure an entry-level position in a hospitality organisation such as a restaurant, hotel, motel, club, pub, café or coffee shop.

High performing students may be offered a position at Mantra Hotel Tullamarine upon completion.

Graduates may go on to find employment in the following positions:

- bar supervisor or team leader
- concierge
- duty manager
- food and beverage supervisor or team leader
- front office supervisor or team leader
- housekeeping supervisor or team leader
- shift manager.



Fees

This training is delivered with Victorian and Commonwealth Government funding.

Eligibility for Government Subsidised Training. Generally, you are eligible for a government-subsidised training place if you are:

- an Australian citizen
- an Australian Permanent Resident (holder of a permanent visa)
- a New Zealand citizen

and are any of the following:

- under 20 years of age
- seeking to enrol in a Foundation Skills List course (and do not hold a Diploma or above qualification or are receiving core skills training in other sectors)
- seeking to enrol in VCE or VCAL
- seeking to enrol in an apprenticeship
- 20 years and older and 'upskilling' by seeking to enrol in a course at a higher level than your existing qualification.

You may be eligible for concession. If you are an Indigenous student the relevant concession tuition fee applies - 20% of the standard fee for a student eligible for government-subsidised training under the Victorian Training Guarantee.

For concession card holders enrolling in a course (certificates I - IV), the relevant concession tuition fee applies - 20% of the standard fee for a student eligible for government-subsidised training under Skills First.

The fees listed below relate to 2019 courses and are indicative pricing only as total costs vary depending on the units you elect to study.

Concessions for Diploma and Advanced Diploma course categories are only available to Aboriginal or Torres Strait Islanders.

Payment plans are available. How does a payment plan work?

When you're enrolling, you'll need to pay a \$250 deposit which is deducted from the total cost of the course (tuition, student services, materials and consumables fees). The remainder of the fees can be paid on a payment plan with our partner Debtsuccess in either weekly or fortnightly instalments over the duration of the enrolment period. When you enrol, you will need to complete and sign an electronic form provided to you our Customer Service Officer to set up the plan and provide your bank or credit card details. A 5.5% administration fee will be applied to the payment plan amount.

We accept payments from savings, cheque and credit card accounts; however AMEX and Diners cards are not accepted. All payments must be completed two weeks prior to the end of the course.



Your total course fee will typically include your tuition fee (table 1), any applicable consumables and/or material fees (table 2) and non-tuition fees such as student support fees (table 3).
