Lesson aims: By the end of the lesson, participants should have understanding on basic driving law in Australia.	
Specific learning outcomes: By the end of the lesson, participants should be able to understand and say: <ul style="list-style-type: none">• Court• Fine• Global Positioning System (GPS)• Lawyer• Legal advice• Valid• Licence• Car registration	Assessment methods: Participants to do an activity sheet to check their understanding of new vocabularies and concepts related to the driving law in Australia.
Previous knowledge assumed: intermediate/advance or have done beginner's lesson on this topic	
Materials and equipment required: Whiteboard, markers, Tablet/Laptop, "Driving Law" YouTube video https://youtu.be/uljD3ZCBSY8 or "Driving law" transcript on page 2 of Teacher answer sheet (if no access to a tablet/laptop with internet connection), "Driving Law – Activity Sheet"
