1. Consent and Use

In relation to the above event or project, I hereby:

- 1.1. consent to be photographed and/or recorded and/or filmed by The Salvation Army;
- 1.2. consent to The Salvation Army using, altering and/or publishing my Appearance (or if applicable, my dependent's Appearance) and/or the Content in the following forms of media:
 - a. the internet (including The Salvation Army's website, social media and other mediums);
 - b. newspapers, newsletters, brochures and other media (whether electronic or hard copy);
 - c. television, DVDs and other visual media; and
 - d. any other promotional material (whether electronic or hard copy);
- 1.3. consent to The Salvation Army owning any and all rights (including copyright) in the photography, recording, filming or other promotional material;
- 1.4. consent to The Salvation Army and/or its representatives, agents and related entities to Use the Content and any photographs, films, videos, digital recordings or audio recordings of my Appearance (or, if applicable, my dependent's Appearance) for promotional, commercial, marketing or any other purpose, in connection with any current or future projects;
- 1.5. waive all moral and personal rights and objections to any Use of the Content and my Appearance (or, if applicable, my dependent's Appearance) by The Salvation Army in connection with any current or future projects;
- 1.6. understand that The Salvation Army has relied on my consent in allowing my (or, if applicable, my dependent's) participation; and
- 1.7. understand that I will not receive any compensation or any form of payment now or in the future for consenting to the above.

2. Revocation

- 2.1. I understand that I have the right to revoke my consent for The Salvation Army to Use the Content and my Appearance (or, if applicable, my dependent's Appearance), by giving written notice to The Salvation Army at the following email address: salvo.studios@salvationarmy.org.au
- 2.2. I understand that the revocation of my consent under clause 2.1 does not apply to any Use of the Content or my Appearance (or, if applicable, my dependent's Appearance) used by The Salvation Army, including in any published material, before I gave written notice revoking my consent. The Salvation Army may continue to Use the Content and my Appearance (or, if applicable, my dependent's Appearance) which were used by The Salvation Army prior to receiving the written notice revoking my consent.



3. Privacy

- 4.3. **Use** means lawful use and includes the exclusive and perpetual right of The Salvation Army in any jurisdiction worldwide to:
- a. use, copy, adapt and/or exploit;
 - b. mix, edit, duplicate, or re-use, or create derivative works;
 - c. assign, license or sub-license;
 - d. publicise and/or market; and
 - e. exhibit and/or perform and/or distribute by any present or future media, for profit or otherwise, and for commercial or non-commercial use.
